RULES & REGULATIONS

1. **TALENT SEARCH PROGRAMME** is not just a Competition as is seen often being held here and there. Sarbabharatiya Sangeet-O-Sanskriti Parishad use to organise the programme on All India basis to find out talented children in various streams of Indian Art & Culture (as mentioned overleaf) who are a bit deficient in expressing themselves while performing.
2. **ELIGIBILITY** : GROUP - A : 6 to 10 Years
GROUP - B : 10+ to 15 Years
3. One may apply for not more than 3 subjects of the Competition, at a time. (Separate Application and Fees required, subjectwise.)
4. No award / certificate is given unless number of Competitors in any subject come up to 20 and / or a candidate obtains 60% marks. Authority may of course decide otherwise, as would be found suitable from time to time.
5. Students coming out to be 1st, 2nd & 3rd (Subjectwise) are allowed to enjoy a Cash Prize of Rs. 2,000/-, Rs. 1,500/- & Rs. 1,000/- respectively, besides Certificates to be given at the Convocation, held for the Session.
6. Candidates holding 1st position in any previous year cannot appear with the same subject. If, by mistake, such repetition is detected (even after the Competition is over) the current application will be treated as cancelled. Same candidate securing 1st, 2nd & 3rd position in more than one subject in the same session will be entitled to a Single Cash Prize for one subject (at his / her choice) only.
7. All successful candidates (getting at least 60% marks) will be given Certificate of Merit.
8. All candidates are to report in time (as mentioned in the Call Letter) alongwith own material / equipment / instrument / accompanist. Dance items will be electronic based (not live).
9. Parishad cannot be held responsible for non-receipt of Call Letter, in time. Late reporting or absence on the date and time of the Competition Schedule on any reason will not be treated as a point of any sort of consideration.
10. Result of the Competitors securing 1st, 2nd & 3rd Position is generally declared at the end of the Competition. The verdict of the honourable judges is final against which no appeal / proceeding / challenge is entertained. Final result may be obtained either from the respective institutions, candidates belong to or from Parishad Office after 40 days (more or less) from the date of completion of the Programme.
11. For attending Convocation, printing photograph in the Souvenir, candidates are to contact office immediately after declaration of the result to observe necessary formalities and payment of respective fees for the same.
12. Any incomplete Application will be treated as cancelled.
13. In Talent Search Test not more than 60 (sixty) competitors in each group and subject will be taken. As soon as the 60 (sixty) is filled up acceptance of Form will be closed.

N. B. : One extra copy of recent photograph should be submitted alongwith the Application Form (duly filled up and signed), attested copy of the Birth Certificate and Entry Fee of Rs. 300/- (per Subject) only, latest by December every year. The Competition is held generally during the month of January.
